## **Description of Placement**

This is a General Adult Psychiatry Post on the inpatient unit and Home Based Treatment Team.

#### Roles and Responsibilities of the Trainee

The job is based at Meadowbrook Unit, which is on the grounds of Salford Royal Hospital. The main responsibilities for the trainee will be working on the Acute Adult Inpatient Unit Two and Half days a week and with the Home Based Treatment Team based at Meadowbrook unit two days a week. There are four wards on the inpatient unit. There is a psychiatric intensive care unit (mixed ward for Salford Patients) called Chaucer Ward; a male recovery ward for Salford patients called Eagleton Ward; a female recovery ward for Salford patients called Keats Ward, and a male recovery ward for Manchester patients called Mc Coll ward. The majority of patients under the care of Dr Umeadi are on Eagleton and Keats Wards. The higher trainee will visit these wards twice a week with Dr Umeadi.

The trainee will work with inpatients and Home Based Treatment Team Patients from a defined geographical area, which is linked to three GP clusters (Clusters 6, 7, & 8) which are managed by Prescott House Community Mental Health Team. The responsibility for individual patients will be decided with respect to GP practices. There will be 2 ward rounds a week; all day Mondays and half day Thursdays. The Monday ward round will be full MDT ward round which will be attended by Consultant psychiatrist, the higher trainee, the core trainee, a GP trainee, an FY1 doctor, a pharmacist, an admin secretary, nurses, and Care Coordinators. The Thursday ward round will be a walk around ward round in the morning with Dr Umeadi, the higher trainee, GP trainee, and core trainee. The higher trainee is expected to attend MDT meeting at Prescott House CMHT on Wednesday mornings and have a specialist interest session on Thursday afternoons.

The higher trainee will work with Dr Umeadi on the Home based treatment team on Tuesdays and Fridays. This will involve seeing 3 patients a day under the Home Based Treatment Team at Meadowbrook unit for medical reviews. Dr Umeadi will be available all day on these days for advice, supervision, and clarification of any doubts.

There is a core trainee, a GP trainee, and an FY1 doctor attached to the post and the trainee will work closely with them having an opportunity to provide training and supervision. The higher is not expected to have any specific caseloads on the in-patient unit but will see all the patients admitted under Dr Umeadi with Dr Umeadi. The average number of patients on admission at every one time is about 10 to 14.

There will be weekly supervision which usually occurs on Wednesday mornings at 11:00hrs. There is a weekly MRCPsych teaching programme which takes place on Wednesday afternoons between

13.00hrs and 17.00hrs. The trainee will also attend special interest sessions on Thursday afternoons. The trainee will participate in second on-call rota.

The trainee will be expected to record histories and mental state examinations on the electronic patient record. The work will be on the inpatient unit at Meadowbrook and Home based Treatment Team also based at the Meadowbrook Unit. They will be expected to make diagnosis after seeing patients and formule initial management plan. They will also be expected write clinical letters to GP after seeing patients under the Home Based Treatment Team.

The trainee will provide support and supervision to the first on-call. There will be an on-call consultant available for advice if required.

There is a 24-hour crisis service in operation.

#### **Academic Activities** (These should include case conferences/Journal Clubs/Lectures etc)

There is a weekly MRCPsych teaching programme on a Wednesday between 13.00 and 17.00. The trainee will be encouraged to attend the MRCPsych course. They will also be expected to provide some input to medical student teaching and physical associate students teaching. The supervision with Dr Umeadi will occur for 1 hour per week between 11.00 and 12.00 on a Wednesdays unless rearranged. There will also be supervision at other times during the week depending on need.

There will be a list of learning objectives agreed within the first week of the post. These objectives and portfolio will be reviewed regularly in supervision. The supervisor will also ensure work place based assessments are completed and that the trainee is prepared for their reviews.

#### **Facilities**

Access to computer and secretarial support. ST Office in Meadowbrook.

#### **Supervision Arrangements**

Trainer provides 1 hour supervision per week. The trainee will attend the two ward rounds on the inpatient unit weekly, attend Home based treatment team morning MDT meetings on Tuesdays and Fridays, and there will opportunities for supervision throughout the week.

#### **Teaching/Academic Experience**

#### **Audit/Research Opportunities**

The Trust has an audit programme which trainees are invited to participate in. There will also be support for individual audits from trainer. Dr Umeadi has a PhD in public health and has good knowledge of research and has interest in research. Dr Umeadi will be available to teach the trainee research methods; and participate in and supervise any research projects the trainee may be interested in.

### **Management Opportunities**

The trainer is the Lead Consultant for In-patients, Home Based Treatment Team, and Rehabilitation Services within the Salford directorate. He has good experience in management and can teach the trainee management and leadership methods, and encourages trainees to engage in various governance and management meetings. The trainer can arrange management projects for the trainees within Salford.
