Trainee Job Description

Description of Placement

Fairhaven is a 10 bedded inpatient unit for ages 13 – 18. Admissions come from 5 Boroughs and beyond under NHSE. Non-emergency admissions are assessed prior to admission by the Fairhaven team.

We comply with most QNIC standards and have a healthy MDT including Psychology, Occupational Therapy, Social Work, Family Therapy and Education. We also have trainees including Creative Therapy. There is 1 FT Consultant C&A Psychiatrist, 1 PT Specialty Doctor and Nursing Staff from Band 2 to Band 7.

Young people are admitted to the unit informally with Gillick Competence or Capacity, formally detained under the MHA or under parental consent. Most have been presenting with risk in the community (usually to themselves) which cannot be managed safely by community services. The origin of this risk varies, it is often due to dysregulation of emotions behaviour and relationships, sometimes to psychosis, trauma or specific mood disorder.

Length of admission varies from a few days to many months.

This post offers the opportunity to develop both competence and confidence in working with a group of significantly unwell, significantly impaired, significantly risky young people within a well-functioning MDT. It will help trainees understand both the importance and the limitations of a psychiatrist's role and will see how it can complement the rest of the MDT.

It will also offer the opportunity to experience how Tier 4 Inpatients coexists and interacts with Tier 3 Community CAMHS and other Community Agencies. The trainee will become familiar with the use of the MHA and MCA and the ethical and legal frameworks within which we care for our young people and their families.

The CT3 will have day to day medical responsibility for up to 5 inpatients including both clinical (physical and mental health) and administration responsibilities, under the appropriate level of supervision of the Consultant. This will include representation at Ward Round and CPAs. Attendance at Tribunals can be discussed.

The CT3 may take part in Tier 4 assessments with Nursing colleagues

The CT3 may take part in MDT interventions depending on their personal interests

They will cross cover the Specialty Doctor for annual or study or sickness leave but will always have Consultant cover available

The CT3 will be based at Fairhaven.

Admission assessment; physical examination; appropriate investigations; initial prescription and ongoing medication regime; response to physical or mental health complaints in liaison with nursing staff; weekly individual therapeutic session with up to 5 young people; report to and plan with MDT in ward round; contribution to CPA and Discharge planning.

The trainee will be encouraged to attend appropriate educational and training events at Hollins Park.

Facilities

The trainee will have an office on Fairhaven with appropriate IT. There is a library at Hollins Park.

Supervision Arrangements

One hour per week supervision will be provided by the supervising consultant to discuss clinical, academic, managerial or career–related issues.

The MDT will be available for informal supervision on subjects of mutual interest

Teaching/Academic Experience

The trainee will be involved in the Warrington trainee academic programme.

There may be opportunity to teach at Fairhaven educational events.

The trainee will be encouraged to attend relevant training events locally and nationally

Audit/Research Opportunities

The trust has a well developed Audit and Research governance Team based at Hollins Park. The Research, Audit and Clinical Effectiveness team support research and audit throughout the trust. Each trainee is expected to undertake audit and present their findings and other academic work as part of their professional development during each rotation. This is in line with Royal College of

The trust is actively involved in research and the trainee can be provided supervision and practical support for research.

This would include Trust clinical management forums, such as Clinical Governance/ Audit Groups, Trainee forum, as well as mainstream training management groups at Trust, Deanery and National (e.g. Royal College) levels.

The trainee will receive advice about wider training issues and will have access to long term career guidance and support.

There are structured induction programmes at trust level addressing various issues such as HR, local clinical safety policies, statutory training including basic life support and immediate life support training amongst others.
