## Description of Placement

This is an in-patient focused job dealing with acutely unwell patients. There is a lot of scope to improve knowledge of the Mental Health Act. Bronte Ward has an exceptional turnover of the patients with acute mental health difficulties and psychosocial difficulties including drug & alcohol related problems, hence an ample opportunity to enhance skills and confidence to meet the high pressure demands of services. The multidisciplinary team working on Bronte Ward are experienced and aim to provide a high quality of care with a high level of patient satisfaction. There is much opportunity to liaise with other teams who input to the ward including the HBTT, CMHTs, EIS.

## Roles and Responsibilities of the Trainee

The inpatient work is based on Bronte Ward. Acutely unwell patients are admitted here for stabilisation of their mental state. Prompt discharge is aimed to the community working closely with the HBTT and relevant CMHTs. The trainee would be expected to take part in adult acute ward rounds on Bronte Ward and to help coordinate the day to day care of these patients.

To be the medical representative at tribunals/management meetings.

To take an active part in medical student and junior doctor teaching.

To provide a leadership role to the core trainees and foundations doctors within the team.

Assessment and treatment of acutely unwell patients in the inpatient setting.

Coordination of pharmacological, psychological and social interventions.

Specialist Registrar will join a well-established on-call rota where they will be supported by the on-site junior (tier 1) doctor and the consultant on the other side.  
The rota is 1:17 and it is a 12 hrs/shift. SpR On-Call covers 3 Hospital basis. Any community assessments would be carried out by the consultant on call.

Trainee will share an office with one other ST4-6 trainee.  
Trainee will have office based facilities including access to a computer and internet.  
Excellent admin support.  
Work mobile telephone.  
Hospital provides a parking place for staff employed by the Trust and there is a large library on the acute site.

**Supervision Arrangements** *(including clinical and educational, including cover arrangements when supervisor absent)*

1 hour/ week Wednesday mornings but there can be flexibility to suit.

The trainee will have opportunity to teach medical students. He/she is expected to teach and supervise his/her junior colleagues when required.  
Opportunity to present audits/research at weekly meetings.  
Opportunities for OSCE's, PBL, CASC, lectures and small group teaching.

Audit/research: 1-2 sessions a week.  
Multiple ongoing Trust audits.
