#### **Description of Placement**

Dr Upton is one of 5 Old Age psychiatrists working out of Mossley Hill Hospital (MHH) providing services to an elderly population of approximately 63,000. Dr Upton's Team serves an elderly population of ~ 12,000 with a variable socioeconomic background and also provides input into the Young-onset Dementia Service.

The Trainee provides in-patient care to patients on Acorn and Oak Wards at Mossley Hill Hospital during Ward Rounds. When required, the Trainee also provides input to Heys Court, a longer-stay functional ward.

The majority of the work is community based and includes assessing and managing older age patients with functional and organic illness, as well as patients referred to the Young-onset Dementia Service.

#### **Roles and Responsibilities of the Trainee**

- To assess, review and contribute to the management of inpatients during Ward Rounds.
- Three outpatient clinics per week, where several new patients and some of Trainee's own follow-ups are seen by the Trainee under supervision of Dr. Upton.
- To maintain up to date electronic and other medical records to a high standard.
- To dictate all letters promptly.
- To work closely with other members of the MDT and to see carers / relatives as required.
- To provide appropriate medical leadership to the team.
- To build towards those skills required for a new consultant in domains such as teaching, supervision and management.

Community assessments will be carried out in patient's own homes and in Care Homes. Occasionally there will be OPD appointments within Mossley Hill Hospital.

Acorn and Oak Wards are in Mossley Hill Hospital and Heys court is approximately 3 miles away. The trainee will attend Ward Rounds on Oak and Acorn Wards.

The role entails assessing and managing older age patients with functional and organic illness, as well as patients referred to the Young-onset Dementia Service, under the supervision of Dr Upton. The trainee will work with the ward and community teams and may

conduct joint visits.

There will be the opportunity for increased experience with the Mental Health Act and Mental Capacity Act. The trainee may be asked to prepare tribunal reports for in-patients and attend tribunals, with the Consultant.

# On Call Please state frequency of on-call and nature of duties plus arrangements for clinical supervision

The trainee will take part in the trust wide Specialist Trainee out of hours shift rota (Evening shifts/ weekend shifts/ night shifts). This is usually between a 1 in 15 and 1 in 20 rota. The trainee covers general adult and old age services when on duty out of hours, and there is always an on call General Adult Consultant and an on call Old Age Consultant available The duties are usually urgent MHA assessments in the community, and advice calls from staff/ GPs. Core Trainees cover the wards on call.

#### Academic Activities (These should include case conferences/Journal Clubs/Lectures etc)

There is a weekly Local Academic Programme held at Ashworth Hospital every Tuesday morning, and the trainees both take part in the case presentations / journal presentations / expert led sessions, and also have the opportunity to chair the meetings. These sessions cover General Adult, Older People, Learning Disability, Forensic, Liaison and Substance Misuse presentations.

The trainee will also attend the regular combined ST forums and the old age ST forum, where again there are opportunities to present cases etc.

access with computer. Higher trainee room in Mossley Hill Hospital. Support of a medical

secretary.

#### Supervision Arrangements

Weekly Supervision with Dr Upton.

#### **Teaching/Academic Experience**

There will be an opportunity to teach Medical Students and Physician Associate Students during their placements with the Team. There will also be the opportunity to supervise and teach junior trainees both day-to-day and on call, and to contribute to the induction programme for each intake of new junior doctors.

#### Audit/Research Opportunities

There will be an opportunity and expectation to become involved in audit during the placement.

There will be the opportunity to supervise the audits of junior trainees as part of their training. The trainee will be supported in their audit by Dr Upton and the Trust audit department. The trainee will have a session for research, and can use this to join / develop research projects within the Trust. The trust is involved in a number of research projects relevant to older adults.

#### **Management Opportunities**

The trainee will develop their management experience throughout the post. They will contribute to management of the teams day-to-day and will be encouraged to utilise management opportunities / courses as appropriate.

#### **Other/Additional Experience**

The trainee will be expected to attend the Trust induction programme and will be encouraged to attend courses / conferences appropriate to their needs and development.

#### **Description of Special Interest Opportunities**

A range of special interest sessions are available, including – Psychotherapy ECT Elderly medicine Movement disorder clinics, etc
